Where is parking located?

Event parking is available on surface lots A and B across from the John McConnell entrance. Parking is \$3.00. (See map on Page 5.)

Where is registration located?

Registration begins at 9:00 a.m. Please enter the west side of the Nationwide Arena at the John McConnell entrance. Then follow signs to the registration area.

What can I expect at registration?

Registration will begin at 9:00 a.m. Challenger participants will receive their t-shirt at registration. An adult attending the event with participants will be asked to fill out an emergency contact form during the registration process. This form will be used if the participant requires assistance at any time during the day, or in case of emergency.

Will lunch be provided for the players?

Lunch will be provided for all players.

What is Challenger Football?

The UCP of Central Ohio Challenger Football Competition allows children with mental and physical disabilities to experience the game of football in a fun and exciting way. To play, Challenger players are teamed up with a Football Buddy. During the game, utilizing the rules of flag football, the Football Buddy catches the ball and hands it off to the player who then runs/wheels, throws, catches and scores. The UCP of Central Ohio Challenger Football Competition allows the players to learn good sportsmanship and make new friends while transforming disabilities into abilities.

What if my child is a football player?

The UCP of Central Ohio Challenger Football Competition is a single-elimination tournament. The first 4 teams will begin playing at 10:00 a.m. Teams of 5 players paired with 5 Football buddies will play against one another. Two games will be played simultaneously at opposite ends of the field between the 20 yard line and the end zone. The winning team will be recognized and awarded their trophies at approximately 6:00 p.m.

What if my child is a cheerleader?

A Cheerleading clinic hosted by the Destroyers Bombshells will take place in the Activity Room from 10:00 a.m. to 1:00 p.m. The cheerleader participants will then move to the arena to cheer from the sidelines during Round 2 of the competition which will begin at approximately 2:00 p.m.

How can I get tickets to the Saturday night, March 29th game when the Destroyers take on the Orlando Predators?

Each player will receive two complimentary tickets to Saturday night's game. Seating will be available in the Sky Terrace.

How long will my child need to be at the Nationwide Arena for the competition?

If your child is on a winning team, he/she may be involved in the competition for several hours. Please make sure to visit the carnival located on the Budweiser Terrace for face painting, balloon statues, magic tricks, and other fun games.

Is photography permitted during the competition?

Photography is permitted in the arena and during the Cheerleading Clinic in the Activity Room.
